RULES FOR CONDUCTION OF «Mister and Miss Lineage 2 2017» EVENT

SECTION 1. GENERAL TERMS

1.1. Event name: Mister and Miss Lineage 2, 2017.

1.2. Terms and definitions used in these Rules:

1.2.1. Event Organizer - Innova Co. S.àr.l

mailing address: 26-28, Rue Edward Steichen, L-2540, Luxembourg.

1.2.2. Rules – a set of regulations described in this document, establishing procedures for the Event.

1.2.3. Event - a promo event "Mister and Miss Lineage 2, 2017", organized and conducted by the

Event Organizer, rules and conditions of which are described in these Rules. The goal of the Event is to draw attention to the Game.

1.2.4. **Game** – a multiplayer online role-playing game "Lineage 2", available on the Internet through <u>https://eu.4game.com/lineage2/play/, https://eu.4game.com/lineage2classic/play/.</u> Event Organizer holds exclusive rights for the Game, in Russia, Ukraine, Kazakhstan, Belarus, Azerbaijan, Uzbekistan, Turkmenistan, Georgia, Armenia, Tajikistan, Kyrgyzstan, Moldova, and the EU and Turkey.

1.2.5. **Prize** – any of the items indicated in article3.11. Event Organizer determines characteristics, models, properties, appearance and other specifications of the Prizes at his sole discretion.

1.3. Event will be held in 2 stages:

Dates of the first stage — from 12:00 (UTC +3) September 11, 2017 to 12:00 (UTC +3) October 23, 2017. Voting period - from 12:00 (UTC +3) October 26, 2017 to 12:00 (UTC +3) October 31, 2017.

Dates of the second stage — from 12:00 (UTC +3) November 9, 2017 to 12:00 (UTC +3) December 6, 2017. Voting period - from 12:00 (UTC +3) December 8, 2017 to 12:00 (UTC +3) December 11, 2017.

Participant's applications for the first stage, with photographs, will be accepted during the period from September 11, 2017 to October 23, 2017.

Results of the first stage will be announced on November 9, 2017.

Participant's applications for the second stage, with videos, will be accepted during the period from November 9, 2017 to December 6, 2017.

The final results will be announced on December 13, 2017.

1.4. Information considering the Event will be posted:

1.5. By participating in the Promotion in accordance with these Rules and by performing actions as set forth thereby, the Participant agrees with the use by the Event Organizer and / or its affiliates and / or their partners of the data provided by the Participant in the ways and for the purposes specified in these Rules.

SECTION 2. REQUIREMENTS TO EVENT PARTICIPANTS

2.1. A person, who wishes to participate in the Event, shall meet the following requirements:

- to live in one of the EU countries and Turkey;
- be the age of 18 or more;
- be completely capable and possess all necessary authorities and data to acquire and implement the rights granted and duties imposed;
- be a registered user of Lineage 2 online game in accordance with the terms of User Agreement <u>https://eu.4game.com/l2ceu-user-agreement//</u> (hereinafter "**User Agreement**") and have an active game character.

2.2. A Participant is a person who meets the requirements described in article 2.1 and completed all of the actions described in article 3.2 of the Rules (hereinafter "**Participant**").

2.3. Event Organizer employees cannot participate in the Event.

2.4. Every Participant:

- shall get fully familiar with the Rules of the Event himself/herself and comply with them;
- shall provide the Event Organizer with reliable information, including in cases and the manner specified by the Rules;
- in case the Participant changes his/her name during the period of the Event, he shall inform the Event Organizer of his new name;
- is entitled to refuse to participate or refrain from participating in the Event;
- in case of winning shall provide documentation described in article 3.16 of the Rules and, if necessary, sign any documentation to get the Prize;
- may not transfer any of his/her rights, related to the participation in the Event, to any third party;
- confirms that participation in the Event and any actions under these Rules do not infringe any rights of third parties, including intellectual property rights;

• confirms, that he/she completely agrees with the Rules (including, *inter alia*, the terms of obtaining a prize) and accepts it.

2.5. Participant acts in person, on his or her own behalf, voluntarily and independently. Participant agrees that according to the applicable law there may be taxes and/or other compulsory fees and charges concerning obtaining of the Prize by the Participant, along with the fact that Participant is responsible for the payment of all such taxes and/or other compulsory charges from the moment of the Prize receipt.

2.6. By participating in the Event, Participant confirms that:

- He/she fully agrees with Rules and will follow them and also approves the use of his or her image and personal data (according to the article 3.16) by the Event Organizer, its affiliates and partners, as well as that he/she provides the Event Organizer, its affiliates and partners with the consent on personal data processing as set forth under the Rules and relevant appendices;
- fully understands conditions and consequences of his/her actions and relevant provisions in these Rules.

2.7. Participant shall independently cover any expenses related to his participation in the Event, including communication services, services of internet providers, travel and all other expenses that Participant may encounter.

SECTION 3. PROCEDURE OF THE EVENT

3.1. The Event and determination of the winners are performed in accordance with these Rules.

3.2. Actions that need to be performed in order to become a Participant. Anyone who wants to participate in the Event should perform all of the following actions within the period from September 11, 2017 to October 23, 2017:

3.2.1. get to know with the Rules in full;

3.2.2. have his/her personal data on eu.4game.com profile in sections for name and surname, appropriately filled out according to Privacy Policy;

3.2.3 complete the quest "Diana's Request" with an active character in the Game using the profile filled out under paragraph 3.2.2. of the Rules;

3.2.4. make a photo that should meet the requirements stipulated in the article 3.3. of the Rules (such photos hereinafter are referred to as "**Photo**" or "**Photos**"):

3.2.5. Attach one Photo that meets the requirements of article 3.3 of these Rules to the participants' application on <u>mrmiss.l2.ru/en/</u>. The procedure for sending Photos is defined in article 3.5 of these Rules;

3.2.6. provide the Event Organizer with all necessary information, according to article 3.5 of the Rules.

One Participant may provide no more than one Photo (articles 3.2.4 and 3.2.5 of these Rules). If Participant submits more than one Photo, the Event Organizer has a right to reject all the Photos or choose one Photo at its discretion. Participation in the category "Mister" and "Miss" is determined depending on the gender of the Participant indicated in the ID, regardless of the gender chosen by the Participant to create an image for the purposes of participating in the Event, including in Photos and / or Video. The Event Organizer is not responsible for and cannot influence the decision of the jury in the voting process, if such decision was influenced by the Participant's choice of image gender, which does not correspond to the gender the ID.

In case of doubt regarding the gender of the Participant, at the request of the Event Organizer, the Participant shall provide the Event Organizer with a copy of the ID, in part that displays name of the Participant, his/her photo and gender. If the document is not provided, the person loses the status of the Participant of the Event.

If the Event Organizer becomes aware of the incompatibility of the category of the Event to which the Participant applied to against the gender under the ID proving the identity, after the announcement of the results of the Event, the Event Organizer has the right to cancel the results where the Participant shall return the Prize to the Event Organizer if such Participant was chosen as a winner.

3.3. Requirements towards Photos:

• the Photo shall be a result of creative work made by the Participant that submits the Photo for participation in the Event;

• The Photo shall display the Participant with clear image of the Participant's face. Photos with any other people than participant are not allowed. As an exception to this provision, it is allowed to use images of persons additional to the Participant on the Photo, if: the use of the image does not allow to identify as a specific person, including if their faces are not visible / hidden; Persons, the image of which is depicted on the Photo with the Participant, gave their consent to use their own image in accordance with these Rules, and that the use of the images is not considered as participation / application for their participation in the Event; participation of such persons is necessary for the embodiment of the creative intention of the Participant to participate in the Event. Involvement of third parties for the creation of a photograph is allowed provided that it does not cause doubts as to who is the main participant in the Event

• The Photo should have a "Lineage 2" logo on it, where the logo shall be a part of the picture and shall not be included into the Photo by using the computer program, and placement of the logo by graphical editors is prohibited;

• The Photo should be on topic "A symbol of Halloween";

• The Photo may be post-processed, but only graphic characteristics may be changed (sharpness, contrast, color balance); adding any painted elements or other items are not allowed. As an exception to this provision, it is allowed to add painted elements to the Photo, if such an addition is necessary to conceal persons additional to the Participant on the Photos and to comply with the requirements for the participation of such persons in accordance with the provision above;

• The Photo (and the title of it) shall not contain:

• results of intellectual activity (music, trademarks, logos, brands, movies, videos etc.) of any third parties, apart from the Participant that provides the Photo for participation in the Event, neither as a whole, nor their fragments;

o results of intellectual activity (music, trademarks, logos, brands, movies, videos etc.) as a whole, or their fragments, created by the Participant, for which he/she does not hold exclusive rights including the results of intellectual activity created under commissioning contracts, labor contracts or any other commercial contracts;

o materials of any form and type, which publication is limited or restricted by the applicable law, including, but not confining materials containing erotic or pornographic scenes, advertising information, acts or incitation to violence, ethnic hatred, discrimination at any basis, insults, profanity, use and/or distribution of any psychotropic or other substances prohibited by law including psychotropic substances words (any forms of expression are prohibited – words, associated visual images and/or other meanings);

p inappropriate materials or objects that the Event Organizer would consider unfit for using in the Event, for reasons of morality and rationality;

- q images of third parties, unless otherwise is set forth in the Rules;
- minimal resolution of the Photo should be no less than 1500x1000 pixels;
- the quality of the Photo should be good enough to clearly perceive objects on the Photo;

• while creation of the Photo the third parties' rights, including intellectual property rights and publicity right shall not be violated (including the right of using person's image, if applicable);

providing the Event Organizer with the Participant's Photo in order to take part in the Event shall not violate any third parties' rights, including rights for the results of intellectual activity;

• Participant is the single author of the Photo and is its exclusive right holder.

The Participant is responsible for compliance with the requirements of the paragraph in full in accordance with applicable law. The Participant undertakes to settle by its own strength and at its own expense requests, claims and actions of third parties arising from or related to the violation of the Rules by the Participant and to release the Event Organizer from liability of any kind.

Photos, which do not meet one or several requirements, are not considered by the Event Organizer and cannot participate in the Event. Event Organizer shall have the right in its sole discretion to determine whether the picture meets the requirements or not, relying on compliance of the Photo to the rules and expectations, applicable to Photos quality. Person who provides a Photo that contains one or several violations, does not gain the Participant status (loses it).

3.4. If the Event Organizer has any doubts about any of the conditions listed in this paragraph below, the Event Organizer has a right to exclude a Participant who provides such Photo from participation in the Event before the winner announcement date.

In case the Event Organizer finds out that (at least one of these conditions), the Participant of the Event will be dismissed:

• the Photo does not meet any of the requirements provided in these Rules;

 \circ the Participant is not the single author of the Photo and is not an exclusive right holder, and does not possess the authorities need (including the right to use the Photo) for participating in the Event;

• any person, whose permission/authorization /approval is required to the extent permitted by applicable law for participation in the Event and/or implementation of any conditions of this Rules, will declare the absence of such permission/ authorization /approval;

• The Photo and/or its containment violates applicable law;

• While performing the actions listed in article 3.2. of this Rules the Participant violates any terms of User Agreement and/or Game License Agreement concerning GAME Client Software, provided by the link: <u>https://eu.4game.com/licence/view/serviceId/1006/type/2/</u> (firstly it is refer to Participants which have used prohibited software during participation in the Event or in other way obtained advantages via infringing the rules of Game agreements);

If such facts are revealed after the announcement of a winner, the Event Organizer has a right to withdraw the results and to claim full compensation for losses from the Participant.

Participant is responsible for providing documentary evidence disproving the facts described in article 3.4 which resulted in exclusion of the Participant or fully or partially withdrawing the results. Such evidence may be sent as notarized copies of necessary documents or their originals to the Event Organizer to the address specified in article 1.2.1 of these Rules. If provided documents do not clear the doubts that the Event Organizer has, the Event Organizer has a right to reject the Participant's application for the Event, by sending him/her a motivated refusal letter.

Providing these documents after the winner announcement date does not oblige the Event Organizer to reconsider the results of the Event.

The Event Organizer allows every Participant to use the Game logo exclusively for purposes of making a Photo or Video for the Event for the period of the Event, including photographing the logo to the extent required for creating a Photo or Video, without changing the existing logo and compiling with other images or other elements of the Photo or Video.

All Participants of the Event shall remove their Photos from internet resources where they are placed for the Event. Usage of the Game logo by the Participants outside the Event is prohibited. Displaying Photos in public places, resources or in the Internet after the Event is prohibited.

If the Participants of the Event violate this provision, the Event Organizer can apply measures to remove the Photos from such resources and, at the request of the Event Organizer, the Participant shall compensate the Event Organizer's damages in full exctrajudicially, including expenses for lawyers, and also cancel the results of the Event in case of which the Participant shall return the Prize to the Event Organizer, if the Participant who posted the Photo is the winner.

3.5. The procedure of the Event:

3.5.1. In the first stage of the Event, persons who meet the requirements (article 3.2) and have performed the actions (article 3.3) described in these Rules and wish to become Participants, send their Photos to the Event Organizer from September 11, 2017 to October 23, 2017.

Persons who wish to participate in the 1st Stage of the Event during the period from September 11, 2017 to October 23, 2017, should complete the following actions:

- Go to the official website of the Event <u>mrmiss.12.ru/en/;</u>
- Fill the application form, indicating his/her name, server, character's nickname, email address and skype contact;
- Upload a Photo that meets the requirements stipulated herein. Any other procedure of sending Photos that differs from the one presented in this article does not meet the Rules.

3.5.2. Participants who have been admitted to the second stage by the Event Organizer, will have to create and send an audiovisual work in the form of video presentation of the Participant that should meet the requirements described in article 3.6 of these Rules (hereinafter – the "**Video**").

Persons, who have been admitted by the Event Organizer to the second stage of the Event and wish to participate in it during the period from November 9, 2017 to December 6, 2017, should upload the Video that meets the requirements described in these Rules to mrmiss.l2.ru/en/.

3.6. Requirements for the Video:

3.6.1 Video should be a result of creative work of the Participant, who provides the Video for the Event; the Participant shall be obligatory and clearly displayed in the Video;

3.6.2. Video should be 15 seconds to 1 minute long excluding main titles and information about the authors;

- 3.6.3. Video should not contain human speech (except song lyrics);
- 3.6.4. Video (including the title of the Video) should not contain:
 - results of intellectual activity (music, trademarks, logos, brands, movies, videos etc.) as a whole, or their fragments, created by any third parties except for the Participant that provides the Video for participation in the Event; in order to avoid conflict with the copyright holder, the Event Organizer recommends the use the music available on the resource: http://youtubecreator.blogspot.ru/2013/09/free-music-for-your-youtube-videos.html
 - materials created by any third party that is not the Participant that provides the Video in order to participate in the Event;
 - results of intellectual activity (music, trademarks, logos, brands, movies, videos etc. including titles) as a whole, or their fragments, created by the Participant, for which he/she is not an exclusive right holder, including the results of intellectual activity, created under commissioning contract, labor contract or any other civil contract;
 - materials of any form and type, which publication is limited or restricted by the applicable law, including, but not confining materials containing erotic or pornographic scenes, advertising information, acts or incitation to violence, ethnic hatred, discrimination at any basis, insults, profanity, use and/or distribution of any psychotropic or other substances prohibited by law;

- inappropriate materials or objects that the Event Organizer would consider unfit for using in the Event, for reasons of morality and rationality;
- demonstration of any persons other than the Participant. As an exception to this provision, it is allowed to use images of persons additional to the Participant in the Video if: the use of the image does not allow him to identify as a specific person including if their persons are not visible / hidden; persons, whose image is used in the Video together with the Participant, have given their consent to use their own image in accordance with these Rules, and also that the use of images is not considered as participation / application for their participation in the Event; Participant of such persons is necessary for the embodiment of the creative intention of the Participant in order to participate in the Event. Attraction of third parties for the creation of a Video is allowed only provided that it does not cause doubts as to who is the main Participant of the Event. The Participant is allowed to use the drawn / graphic elements in the Video only to avoid identifying the images of third parties that participate in the Video additionally to the Participant.

Videos that do not meet one or more of the above requirements are not considered by the Event Organizer and are not accepted for participation in the Event. The Promoter has the right to determine at its own discretion whether the Video meets the requirements, based on the degree of compliance of the work with the Rules and expectations for the Video by the Event Organizer. The person who sent the Video in violation of one or more of the above requirements, loses the status of the Participant.

The Participant is responsible for compliance with the requirements of the paragraph in full in accordance with applicable law. The Participant undertakes to settle by its own strength and at its own expense requests, claims and actions of third parties arising from or related to the violation of the Rules by the Participant and to release the Event Organizer from liability of any kind.

3.6.5. Video should reflect creativity of the Participant and be adequate to the Events theme. The second stage theme: « Summon and Conquer».

The Event Organizer allows every Participant to use the Game logo exclusively for purposes of making a Video for the Event (for the period of the Event), including demonstrating the logo to the extent required for creating a Video, without changing the existing logo and compiling with other images or other elements of the Video. For Winners of the Event such period expires at the moment of signing the contract of granting the exclusive rights for the Video. For the rest of Participants, it expires on the last day of the Event.

All Participantsshould destroy their Videos, and remove them from internet resources where they are placed for the Event. Usage of the Game logo by the Participants outside the Event is prohibited. Displaying Videos in public places, resources or in the Internet after the Event is prohibited.

If the Participants of the Event violate this provision, the Event Organizer can apply measures to remove the Video from such resources and, at the request of the Event Organizer, the Participant shall compensate the Event Organizer's damages in full exctrajudicially, including expenses for lawyers, and also annul the results of the Event , if the Participant who posted the Photo is the winner in case of which the Participant shall return the Prize to the Event Organizer.

By participating in the Event and sending Photos to the Event Organizer, the Participant confirms that:

- he/she fully agrees with the Rules and will not infringe them while participating;
- he/she has all authorities necessary for participating in the Event and sending Photo and Video for participation in the Event;

- Photo and Video should completely meet all the requirements, described in these Rules;
- information, provided by the Participant is complete and reliable;
- he/she approves usage of his or her image and personal data (according to the article 3.16) by the Event Organizer and its affiliates, as well as that he/she provides the Event Organizer and its affiliates with the consent on such data handling;
- provides Event Organizer and its affiliates with the rights to use Photo and Video on the conditions of nonexclusive free license (including communicating it to public, displaying, public demonstration, distribution, using as part of complex objects, processing of Photo and Video (including modifying size and quality of Photo and Video) and using by any other means without restrictions) worldwide for the duration of the exclusive rights to the Photo and Video on a gratuitous basis, and confirms that he has the necessary authorities to grant this license for the Photo and Video to the Event Organizer;
- he/she confirms his/her approval of the Photo and the Video publishing by the Event Organizer, its affiliates and partner including anonymously without indicating the name of the person;
- confirms the agreement that the Event Organizer has the right to provide Photos and / or Videos with a preface, afterword, comments and other explanations, to use as part of other, including composite and derivative, objects of intellectual property;
- change the name of the Photo and the Video;
- he/she confirms his/her approval to publishing and further use of his/her image contained in the Photo and the Video by the Event Organizer, its affiliates and partners for demonstration on the official websites and online resources of the Event Organizer, its affiliates and the partners, and other Internet-resources including profiles of the Event Organizer, its affiliates and partners in online social networks, information about the progress and results of the Event, as well as for marketing purposes;
- he/she confirms use of the Photo and the Video under the personal name, specified in the Registration card, alias, and specified name (if applicable);
- Game's logo will be used only for the purposes of creating Photo and Video for the Event.

3.7. Terms of processing of the works sent by the Participants and determination of the winner:

3.7.1. The results of the first stage of the Event will be determined from October 31, 2017 to November 1, 2017. On November 9, 2017 the Event Organizer will publish a list of Participants who successfully passed the first stage of the Event and are accepted to the second stage of the Event at the Event's official promo webpage <u>mrmiss.l2.ru/en/</u>.

3.7.2. The results of the second stage of the Event will be determined from December 11, 2017 to December 13, 2017. On December 13, 2017 the Event Organizer will publish a list of Winners (hereinafter the "Winner" or jointly the "Winners") of the Event at the Event's official promo webpage <u>mrmiss.l2.ru/en/</u>.

3.8. Participant's works will be rated in accordance with the criteria described in article 3.9 by the users and Lineage 2 team.

3.9. Winners of the Event will be defined using the following criteria cumulatively:

- 3.9.1. Criteria for determining the Participants who have successfully passed the first stage of the Event and were accepted to the second stage of the Event:
 - conformity with the topic of the first syage of the Event;
 - originality of the idea;
 - image quality: Photo should be clear;
 - art and aesthetical value of the Photo;
 - compliance with the requirements described in paragraph 3.3 of the Rules;

3.9.2. Criteria for determining the Participants who have successfully passed the second stage of the Event:

- plot of the Video;
- picture composition;
- footage quality: accuracy and smoothness of camera handling; originality of the Video idea;
- design: accompanying sound, video effects;
- compliance with the requirements described in paragraph 3.6 of the Rules;
- title frame and information about the authors would be considered as a bonus. The time of placement of such frames is not taken into account when calculating the length of the Video in accordance with paragraph 3.6.2. Rules.

3.10. Compliance of the Photo and the Video sent by a Participant, with the criteria described in article 3.9 of the Rules, will be proved by two groups of jury – users and Lineage 2 team, based on their sole discretion.

Voting procedure

Users and Lineage 2 team rate the Participants' Photo and Video. Each user has 1 vote to be given to a male participant and 1 vote to be given to a female participant, each member of Lineage 2 team has 200 votes to distribute between male participants and 200 votes to distribute between female participants. The Winners are determined by the sum of the total voting points.

3.11. Depending on the degree of compliance of the Photo and Video with criteria described in article 3.9 of these Rules and quantity of the jury voices, the Participant may be recognized as the Winner of the award of a certain place (of 3 places: 1st to 3rd) which gives right to receive a Prize:

Ladies:

- 1st place prize: OMEN Gaming laptop by HP (the model defined by the Event Organizer in its sole discretion);
- 2nd place prize: OMEN Monitor by HP (the model defined by the Event Organizer in its sole discretion);

• 3rd place — prize: OMEN by HP Keyboard, Mouse and Headset (the model defined by the Event Organizer in its sole discretion);

Gentlemen:

- 1st place prize: OMEN by HP Gaming Laptop (the model defined by the Event Organizer in its sole discretion);
- 2nd place prize: OMEN by HP Monitor (the model defined by the Event Organizer in its sole discretion);
- 3rd place prize: OMEN by HP Keyboard, Mouse and Headset (the model defined by the Event Organizer in its sole discretion);

All Winners receive 5000 bonuses and 3 months of Premium account in Lineage 2 or 3 months subscription in Lineage 2 Classic in 4game. The Event Organizer determines an additional prize at his own discretion..

The images of the Prize displayed at mrmiss.12.ru/en/ site may differ from the actual prizes.

In case there arise any problems with delivery of the Prize to the Winner, the Event Organizer chooses an alternative way of purchase and / or delivery the Prize in coordination with such Winner.

3.12. The final results of the Event will be published on the webpage mrmiss.l2.ru/en/ on December 6, 2017. Event Organizer will place information (names, birth dates) about the Winners and prize-winning places the Winners will be granted.

The Event Organizer has the right to publish Photos and Videos sent by the Winners, and publish Photos and Videos sent by other Participants who are not chosen to be the Winners of the Event, however, which, in the opinion of the jury, are made at a high creative level. In order to publish the Photos and the Videos, the Event Organizer may request scanned copies of the Winners and other Participants' ID (with personal photo). In case such copies are not provided, the Event Organizer has a right not to post Winners and other Participants' Photo or Video on the website.

3.13. The Participant who was chosen to be the Winner of the Event, will have to additionally contact the Event Organizer via email not later than January 4, 2018 to confirm the conditions of filling and forwarding documents, stated in the article 3.16 and also the way and the procedure of receiving the Prize. The way and the procedure of receiving the Prize, date, time and place of receiving the Prize, and the evaluation of completeness, accuracy and timeliness of all data provided by the Participant, is done by the Event Organizer at his own discretion.

3.14. Replacing the Prize with money compensation is not provided by the Rules and is not provided by the Event Organizer.

3.15. If the Winner refuses to receive the Prize and / or fails to exercise the right to receive it in the order determined by the Event Organizer and/or does not perform actions that are necessary and sufficient for receiving it under the Rules, before January 4, 2018 inclusively, the Event Organizer has the right to dispose of the Prize in its sole discretion.

3.16. The Prize may be awarded to the Winner immediately after the submission of a passport or other document proving his identity in accordance with the requirements of the EU laws, such as:
